UPON MY ARRIVAL I OBSERVED A GREY IN COLOR NISSAN VERSA BEARING FLORIDA TAG #PWHK99 PARKED IN THE DRIVEWAY. I WAS ADVISED BY DEPUTY H. KOCH #6194 THAT THE LISTED VEHICLE HAD TWO VISBLE BULLET HOLES. DEPUTY KOCH ALSO ADVISED ME THAT REPORTEE/VICTIM, JAHKYRI JAMES WAS ON SCENE AND HIS BROTHER, VICTIM, OMAREA JAMES HAD BEEN SHOT IN HIS SIDE AND WAS TAKEN TO THE HOSPITAL VIA AMBULANCE.

I OBSERVED TWO BULLET HOLES IN THE LISTED VEHICLE. ONE WAS ON THE LOWER PORTION OF THE FRONT BUMPER AND ONE WAS IN THE FRONT PASSENGER DOOR. THE BULLET HOLE IN THE FRONT PASSENGER DOOR ENTERED THROUGH THE DOOR AND EXITED THROUGH THE INTERIOR DOOR PANEL AND THEN ENTERED VICTIM OMAREA JAMES.

I CONDUCTED AN AUDIO RECORDED INTERVIEW WITH REPORTEE/VICTIM, JAHKYRI JAMES. HE STATED THAT HE AND HIS BROTHER, VICTIM, OMAREA JAMES, WERE AT THE BP GAS STATION LOCATED AT, NORTHWEST 110TH AVENUE AND WEST HIGHWAY 40 TO PURCHASE CHIPS AND DRINKS. VICTIM JAHKYRI STATED HE WAS DRIVING THE LISTED VEHICLE AND VICTIM OMAREA WAS RIDING IN THE FRONT PASSENGER SEAT. HE STATED THAT THEY LEFT THE GAS STATION PARKING LOT AND HEADED NORTH ON NORTHWEST 110TH AVENUE. VICTIM JAHKYRI STATED THAT HE OBSERVED A VEHICLE FOLLOWING THEM BUT DID NOT PAY ATTENTION TO IT. HE STATED HE WENT TO TURN INTO HIS NEIGHBORHOOD ON NORTHWEST 5TH STREET OFF OF NORTHWEST 110TH AVENUE AND AS HE WAS TURNING. HE HEARD THREE GUNSHOTS. VICTIM JAHKYRI STATED HE OBSERVED A DARK IN COLOR

FOUR DOOR SEDAN AND VICTIM OMAREA STATED "I WAS HIT". HE STATED HE CONTINUED TO DRIVE TO HIS HOUSE TO CALL 911 IN A SAFE PLACE. HE STATED HE DID NOT KNOW WHO WOULD HAVE DONE THIS AND DID NOT SEE ANYONE AT THE GAS STATION THAT HE KNEW.

ON 2/1/2021 I RESPONDED TO THE BP GAS STATION LOCATED AT NORTHWEST 110TH AVENUE AND WEST HIGHWAY 40 TO COLLECT VIDEO SURVEILLANCE FROM THE TIME THE VICTIMS WERE THERE. VIDEO SURVEILLANCE SHOWS ON 1/31/2021 AT 1838 HOURS, THE VICTIMS ARRIVE AT THE GAST STATION IN THE GREY NISSAN VERSA. AT 1839 HOURS YOU CAN OBSERVE A SILVER BMW FOUR DOOR SEDAN PARK AT THE FRONT OF THE GAS STATION, IN THE FRONT PASSENGER SEAT OF THE BMW, YOU CAN SEE A WHITE MALE WITH A (BLOWOUT) STYLE HAIR CUT AND A BEARD, WEARING A WHITE JACKET. THIS SUBJECT WAS IDENTIFIED BY DETECTIVE SPRATLIN AND I AS DEFENDANT, NATHANIEL JAMES WOODRUFF. THE VIDEO SHOWS THAT THERE IS AT LEAST THREE OCCUPANTS OF THE VEHICLE, A DRIVER, THE DEFENDANT AND A BACKSEAT PASSENGER. NONE OF THE OCCUPANTS OF THE BMW EXIT THE VEHICLE AND ENTER THE GAS STATION. YOU CAN OBSERVE THE DEFENDANT AND THE BACKSEAT PASSENGER WATCH THE VICTIMS VEHICLE AND WATCH THEM EXIT THE STORE. WHEN VICTIM OMAREA EXITS THE STORE, YOU CAN SEE THE BACKSEAT PASSENGER OF THE BMW LAY DOWN OUT OF VIEW. THE VICTIMS BACKOUT OF THEIR PARKING SPOT AT 1841 AT WHICH TIME YOU CAN SEE THE BMW EXIT THEIR PARKING SPOT AND FOLLOW THE VICTIMS.

ON 2/2/2021 I RESPONDED TO OCALA REGIONAL MEDICAL CENTER TO CONDUCT AN AUDIO RECORDED INTERVIEW WITH VICTIM, OMAREA JAMES. HE STATED THAT HE AND HIS BROTHER WERE AT THE BP GAS STATION BY THEIR RESIDENCE TO GET DRINKS AND CHIPS. HE STATED THAT HIS BROTHER VICTIM, JAHKYRI JAMES WAS DRIVING THE VEHICLE AND THEY LEFT THE STORE TO GO HOME. HE STATED THAT HE HEARD GUNSHOTS AND THEN HAD A SHARP PAIN IN HIS SIDE AND NOTICED HE WAS BLEEDING AND BEEN SHOT. VICTIM OMAREA STATED HE DID NOT KNOW WHO WOULD HAVE DONE THIS AND DID NOT RECOGNIZE ANYONE AT THE STORE. VICTIM OMAREA ALSO STATED HE DID NOT GET A DECSRIPTION OF THE VEHICLE.

AFTER SPEAKING WITH MEDICAL PROFFESIONALS I WAS INFORMED THAT THE BULLET WAS LODGED IN VICTIM OMAREA JAMES'S SPINE AND THAT HE MAY BE PARALYZED.

ON 2/5/2021 I WAS NOTIFIED THAT DEFENDANT NATHANIEL WOODRUFF WAS IN THE LOBBY OF THE MARION COUNTY SHERIFF'S OFFICE. THE DEFENDANT WAS BROUGHT TO INTERVIEW ROOM 1 FOR AN AUDIO AND VIDEO RECORDED INTERVIEW. I READ THE DEFENDANT HIS MIRANDA RIGHTS FROM AN AGENCY ISSUED CARD AT WHICH TIME HE AGREED TO TALK WITH ME.

THE DEFENDANT WAS ASKED ABOUT HIS WHEREABOUTS ON 1/31/2021, AT WHICH TIME HE STATED THAT HE WAS FISHING WITH HIS BROTHER ANTONINO WOODRUFF. (TUKK) SAUL

GARCIA MACIAS AND (CHICO) JASON HERNANDEZ. HE STATED THEY WERE FISHING AROUND 1900 HOURS AT THE TUBER'S EXIT ON THE RAINBOW RIVER. I THEN MADE THE DEFENDANT AWARE THAT HE WAS ON SURVEILLANCE VIDEO AT THE BP GAS STATION DURING THAT TIME FRAME. THE DEFENDANT THEN ADMITTED TO BEING IN THE VEHICLE DURING THE SHOOTING BUT STATED HE DID NOT PULL THE TRIGGER. THE DEFENDANT STATED THAT (TUKK) WAS THE ONE WHO SHOT AT THE VICTIMS. THE DEFENDANT STATED WHEN THEY PULLED INTO THE STORE CHICO AND TUKK TOLD HIM TO STAY IN THE VEHICLE AND STATED THAT THE "OPPS" (SLANG TERM FOR OPPONENTS) WERE HERE.

THE DEFENDANT WAS PLACED UNDER ARREST AND TRANSPORTED TO THE MARION COUNTY JAIL.
