

Before me this date personally appeared STOCKMAN, R. #917 who being first duly sworn deposes and says that on the 01/01/2018 / 1145 Hl at 176 SEBREEZE CIR, KISSIMMEE, FL 34744 the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

On 01/01/2018 at approximately 1140 hours this agency responded to the area of Seabreeze Circle in Osceola County in reference to a stolen motor vehicle in motion. The stolen vehicle was black 2015 Cadillac Escalade bearing Florida Tag#BHRR35 which had been reported as stolen out of Orange County, Florida. Deputy Sheriff A. Eddy ID#2244 observed this defendant driving/in actual physical control of this stolen vehicle in the area of Osceola Parkway and Seabreeze Circle. The defendant stopped the vehicle in front of 176 Seabreeze Circle, Kissimmee, Florida and fled on foot along with other juvenile passengers. The defendant was detained and arrested a short distance away on Seabreeze Circle. The defendant did admit post miranda to being the driver/operator of the stolen vehicle and to not ever having had a valid driver license. The defendant was transported to the Orange County Regional Juvenile Detention Center on Grand Theft Auto charges where he was held. The defendant was on active juvenile probation at the time of this offense. I issued the defendant Uniform Traffic Citation# A1JYEFP for a violation of FSS 322.03-1 which he signed and his fingerprint was attached to. I affirm through the above charging affidavit that I have probable cause to believe that on January 1st, 2018 at approximately 1140 hours in the area of Seabreeze Circle and Osceola Parkway in the County of Osceola, Florida the defendant - a child - did unlawfully and knowingly operate a stolen motor vehicle without a valid driver license. This charging affidavit and UTC is being forwarded to the State Attorney's Office for review and further prosecutorial action.
