On August 13, 2022 I Officer Matthew Lafleur ID#15 was conducting a routine property check of the Downtown Beach Access of Minuteman Causeway and the general area of Tropics Cocktail Bar. While in the area I noticed a white male, later identified as Jonathan Hosmer of Melbourne, passed out on the metal bench in front of the bar. As I approached the individual his hat and phone were lying on the ground and the phone was actively ringing. I asked the defendant for his Florida Driver's License which he complied. He was apparently intoxicated and stated that he was sleeping because he had been drinking at the bar. I attempted to question and assist the defendant to find his friends or anyone who could care for him that were still downtown. At this time the defendant became belligerent to my requests to assist him medically and to help also remove him from the area. He began to become aggressive towards our questions and attempts to assist. Jonathan actively resisted by refusing to answer our reasonable questions and by actively resisting by pulling away from me as we attempted to take him into custody.

As I attempted to place the defendant into my vehicle he again actively resisted my attempts to place him into my vehicle by fighting and becoming stiff and ridged so that myself and other officers present had to escalate our force. As he continued to resist my attempts to safely place him into my vehicle a fellow officer utilized agency issued capsaicin spray to gain compliance. Once inside my vehicle Jonathan became agitated and slipped his hand cuffs from the behind his back position to the front of his body. He actively kicked and punched my rear window, and rolled down the back cabin windows yelling and screaming at the general public in the area and at the restaurant within feet of us.

Again, fellow officers and I had to remove Jonathan from the back seat of my vehicle and readjust my cuffs, and secure him in a leg hobble. During this time the defendant's actions caused a chaotic and disorderly scene in the downtown area with patrons present disturbing their general peace, safety, and security. Additionally, while attempting to remove the defendant from my vehicle his hands were cuffed but free to use against officers present. During this time Jonathan struck my fellow officer with his clinched fists, by striking him in the chest and stomach area while we were physically struggling to gain control of him as he flailed and resisted.
